Registration Policy

REGISTRATION

To register for a course, a completed registration form must be received, with payment in full (to IBAH) prior to the start date. We accept certified cheque, money order or via our online registration MasterCard, VISA, American Express and PayPal payment. Courses are filled on a first come, first served basis.

DEADLINES

The cut off for registration is ten (10) business days prior to the start date. Late registrants may be accepted space permitting; however, enrollment may be subject to a late registration fee.

TRANSFERS

Transfers from one program to another or from one individual to another are permitted but there is a transfer fee of \$75.00 depending on the circumstances.

CANCELLATION

Written notice (email accepted) must be received prior to the start of the date.
